TERMS OF SERVICE

Overview

This website is operated by Circo Global LLC, an affiliate of MSCHF. Throughout the site, the terms “we”, “us” and “our” refer collectively to Circo and its parent company MSCHF. Circo offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site and/ or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Terms of Service”, “Terms”), including those additional terms and conditions and policies referenced herein and/or available by hyperlink. These Terms apply to all users of the site, including without limitation users who are browsers, vendors, customers, merchants, and/ or contributors of content.

Please read these Terms carefully before accessing or using our website. By accessing or using any part of the site, you agree to be bound by these Terms. If you do not agree to all the terms and conditions of this agreement, then you may not access the website or use any services. We reserve the right to refuse service to anyone for any reason at any time.

Credit card information is always encrypted during transfer over networks.

The headings used in this agreement are included for convenience only and will not limit or otherwise affect these Terms.

Specific Conditions for *MSCHF Plays Venmo* (“MPV”):

- **To participate in MPV, you must register by June 27, 2024 @ 2pm ET; registration requires submission to us of both \$10 (the “Entry Fee”) and your Venmo username. Failure to use your real Venmo username will prohibit you from obtaining any MPV proceeds, as described below.**
- **The MPV experience begins on June 27, 2024 at 2pm ET and ends upon the earliest to occur of any single participant receiving 100% of the ‘Elect-a-Winner’ votes (as described below) or the experience being placed in a dead state by Circo.**
- **As a participant in MPV, you can vote (once per hour) to ostracize another participant from any further participation in MPV.**
- **As a participant in MPV, you can vote (once per day) to elect another participant (or yourself) as the winner of MPV.**
- **Every hour, the participant (or participants, if tied) with the most “OSTRACIZE” votes is eliminated from MPV. Being ostracized removes all “ELECT” votes that the participant has cast or received. Ostracized participants forfeit their Entry Fee and can no longer vote. Each hour, upon participant elimination, all “OSTRACIZE” votes reset to zero.**

- In the event that a stalemate arises (e.g., only two players remain and each votes to “OSTRACIZE” the other), MPV may, at the discretion of Circo, end without a Winner.
- Payment to the Winner will occur by a payment from us to the Winner’s actual Venmo account. You must use a real Venmo USERNAME when registering to play, otherwise, if you are the Winner, you WILL NOT BE PAID OUT!
- You understand and acknowledge that MPV is not an investment opportunity, and that Circo and MSCHF, as a result, are not offering any investment returns or any promise of investment returns. Instead, upon submission of an \$10 Entry Fee, Circo will make available to you the opportunity to participate in MPV.
- If you are the Winner of MPV, we may require you to complete, sign, and submit a W9 form before we will release any payment to your Venmo account.
- The Entry Fee is used by Circo to provide the Service.

You acknowledge that if you are the Winner of MPV, your proceeds may be subject to federal income tax withholding. You agree to hold us harmless from any liability, including but not limited to, additional tax, penalties, interest and professional fees resulting from your use of the Service.
